VITA (Volunteer Income Tax Assistance) Now Available The Internal Revenue Service's Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE) programs offer free basic tax return preparation to qualified individuals. The VITA program has operated for over 50 years. VITA sites offer free tax help to people who need assistance in preparing their own tax returns, including: • People who generally make \$60,000 or less . Persons with disabilities; and . Limited English-speaking taxpayers In addition to VITA, the TCE program offers free tax help, particularly for those who are 60 years of age and older. specializing in questions about pensions and retirement-related issues unique to seniors. While the IRS manages the VITA and TCE programs, the VITA/TCE sites are operated by IRS partners and staffed by volunteers who want to make a difference in their communities. The IRScertified volunteers who provide tax counseling are often retired individuals associated with non-profit organizations that receive grants from the IRS. VITA and TCE sites are generally located at community and neighborhood centers, libraries, schools, shopping malls and other convenient locations across the country.
