## Committees:

<u>Guardianship</u>- March 27<sup>th</sup>; attendees get up to 14 CEUs to attend, 50 registered so far, setup is at 1 pm on 3/26. Vendors at 2 pm.

Liz brought up the idea of applying part of the profit from conference toward scholarship with U of W for a guardian to attend. Program cost is \$3700.
