We have our first speaker of the year this month, too! We will learn about the latest senior scams and how we can help.

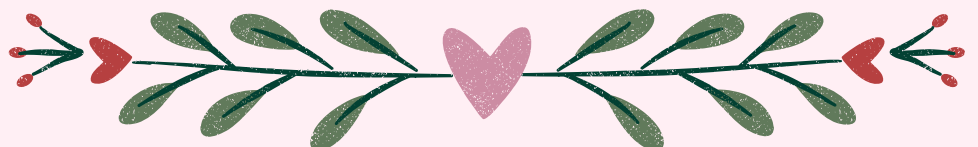

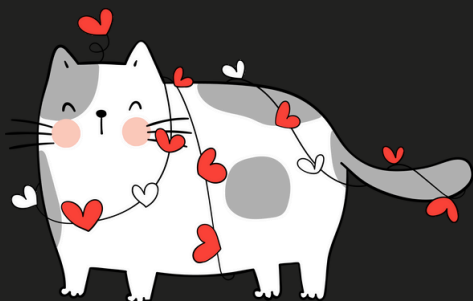
